Description

In regards with the improvement of the infrastructural system connection of the port of Civitavecchia with the Orte intermodal hub, Monte Romano east - Civitavecchia S.S. 675, the contract includes the construction of the 1st section Monte Romano east - Tarquinia, throughout the implementation of a new road section with separate carriageways, with 2 lanes in each direction, for a total length of about 5

km

Description

The project involves the construction of a variant of the SS 42 national road, to bypass the town of Edolo, in the province of Brescia. The road has a **total length of about 2 km** and includes the following works: **the EDOLO tunnel** (about 1.8 km long, about 1.4 km with natural excavation) and **the bridge over the river Oglio** (about 60 m long).

Description

Construction works for the doubling of the **Genga-Serra San Quirico** railway section on the Orte-Falconara line.

The project involves the construction of **a new line of about 9 km**, of which 7 in variant and 2 in addition to the existing line. The works include **6 tunnels** (total length 5 km), **4 viaducts**, a new road, as well as the construction of a railway station in Genga, which will be the gateway to the tourist center of the Frasassi Caves.

The project consists in the construction of, **a new railway track alongside the existing one which will extend for about 4 km** between the Movemente Station (km 228) and the Albacina station. It includes the removal of a level crossing, replaced by a modern subway, and improves the accessibility and safety of Albacina station.

Description

Construction of the Lotto 2A - Phase 1 passenger terminal extension of Venice airport.

The project includes the expansion of the passenger terminal in the North side with a **new surfaces of approximately 14,300 square meters**, through the construction of a new volume and a temporary pier of connection to the existing terminal.

The new terminal expansion is distributed on 4 levels that contain: depots, new Schengen boarding halls on the front of the aircraft yard, arrivals, commercial and technical rooms serving public areas.

The extension will guarantee a length of the South platform of approximately 870 m of which approximately operating 810 m, to accommodate two ships mothers in contemporary. The new part of terminal will be able to assure the operativity of two platform cranes STS (Ship to Shore). The works will be carried out through a scaffold per day on drilled poles of large diameter.
